

#### Smart Rewards Dec 2024 - Senoko Energy x Pelago - Disney Garden of Wonder Lucky Draw

# Terms and Conditions

- 1. This Lucky Draw (the "Lucky Draw") is organised by Senoko Energy Supply Pte Ltd (the "Organiser").
- 2. By registering or taking part in this Lucky Draw, you agree to be bound by these Lucky Draw Terms and Conditions and the decisions of the Organiser in relation to and in connection with this Lucky Draw.

## **Qualifying Period**

3. The Lucky Draw period is from 21 to 24 Dec 2024, both days inclusive, or otherwise modified. Any entries submitted after the cut-off period will not be considered.

## Eligibility

Furthermore, the Organiser shall have no liability for any submission that is lost, intercepted, or not received by the Organiser.
- 7. The Organiser accepts no responsibilities for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
- 8. Participants agree that the Organiser shall not be responsible or liable for any losses, damages or injuries of any kind resulting from participation in the campaign or any campaign-related activity.

- Prize
